Secretary's Report

Dear Member

It gives me great pleasure in presenting the General Secretary's report in the 17th Annual General Meeting of SROWA.

Following is the gist of activities of SROWA since the last AGM held on 15.10.2023:

1. Pension issue under CMPS 1998:

The next hearing of the W.P (C) 3118/2015 pending in high court of Delhi on the issue of revision of pension under Coal Mines Pension Scheme 1998 (CMPS 1998) is on 16.01.2025, due to frequent changes in the bench of judges and other reasons the court case is delayed. By February 2025, it will be a decade since we filed the case in Supreme court in February, 2015. Though it is not meeting our aspirations, in March this year Government took a decision to enhance the minimum pension to Rs.1000 per month. It is also understood that BOT of CMPFO held meetings in the recent past for discussing steps to be taken for sustainability of the pension fund.

The issue of revised Pension Pay Orders (PPOs) is being rigorously followed up with both the Regional commissioners offices (Kothagudem and Godavarikhani) of CMPF and ATB cell of SCCL's corporate office. Sri.Venu Valmikam and Sri.A.B. Prasad are making day to day efforts on the issue. It is heartening to learn that so far 772 revised PPOs have been issued and another 100 are in process.

- 2. CPRMSE: Our Association is regularly taking up with Director (PA&W) and other Directors and also with concerned officials of SCCL for hassle-free cashless treatment in the empanelled hospitals and other matters. It is being assured by the management that CGHS tariff will be applied instead of NIMS tariff and online bill settlement process will be implemented as prevalent in CIL.
- 3. Executive Defined Contribution Pension Scheme 2007 (EDCPS 2007):

 The issue of compensatory interest on EDCPS accumulations from 01.01.2007 to the date of transferring the funds to the fund manager (LIC) has been successfully resolved. It would not have been possible but for the day to day follow up with the concerned officials by the office bearers of SROWA. Special mention has to be made about the relentless efforts made by Sri.A.B.Prasad, our EC member in this regard. It is heartening that eligible retired executives are receiving monthly annuities with effect from 1st October, 2024.
- 4. Arrears of PRP (from 2007-08 to 2013-14):

The writ petition filed in Telangana high court by 350+ retired executives on the issue of PRP arrears was decided in favour of the retired executives in February 2024. As a letter has to come from the Energy department regarding the approval of the MoU ratings for the period 2007-08 to 2013-14, rigorous follow up is being made with C&MD SCCL and Energy department of Telangana government. The petitioners in the interest of smooth implementation of the court decision have adopted a friendly and conciliatory approach towards the management of SCCL and government, reserving their right to knock the doors of the court in case of undue delay in the process. It is hoped that by November 2024, the PRP arrears will be paid.

5. Liaison with CMOAI-SCCL branch:

I am extremely happy to inform you that we are maintaining very good relationship with CMOAI-SCCL branch especially with regard to payment of PRP arrears from 2007-08 to 2013-14.

- 6. On behalf of SROWA, General Secretary attended the AGM of Federation of Coal Industry Retired Employees Association on 17.03.2024 at Nagpur.
